ON-CAMPUS/FACE TO FACE STUDENT OPTIONS

The 2020-2021 school year has looked much different than any year before it. Students and their families, teachers, and administrators have worked tirelessly together to learn and teach through a pandemic year. Some students have soared many have remained steady, but others have experienced significant challenges. Recognizing the diverse needs of their students, several BCSD middle schools, including CBM, are creating specialized opportunities to provide support for students requiring academic recovery and enrichment for academically successful students.

"We knew this was going to be a challenging year," said BCSD Superintendent Dr. Eddie Ingram. "Our students, families and educators have given us all they have despite difficult circumstances beyond their control. I am proud of what we have accomplished, but I realize that there is still work to be done. Our middle school principals have worked together offer a choice opportunity that will serve every student who elects to participate."

The middle school's recovery and enrichment opportunities will be tailored to the needs of students at specific school sites. The programs will begin on June 1 and will conclude on June 17. Student eligibility will be based on their projected final grades (F1) in core content classes (ELA, math, science, and social studies) prior to State testing.

Students who have a final average of 70 or above in all core content will participate in **Specialized Enrichment Projects**. Students who do not have a final average of 70 or above in all of their core classes will participate in Targeted Content Recovery.

Parents have the choice to have their students on-site or at home based on their child's academic progress this school year. School teams and teachers will be reaching out regarding student needs in the next week with additional information. Parents will receive communication from the school regarding the best program placement for their child based on needs assessments and family circumstances.

### **Specialized Enrichment Project**

These projects are for students with a final average of 70 or above in all core classes. Work will be assessed weekly.

- Face to Face families whose student(s) meet this criteria will have the option to have their student(s) participate from HOME virtually OR remain face to face on campus.
  - BDL students who qualify will continue to participate from home.

Attendance for virtual students will be taken daily at a scheduled check-in.
