#### **INTRODUCTION**

This lawsuit was filed a few days ago on December 8, 2021, and the plaintiffs are employees ("3M Plaintiffs") of the 3M Corporation ("3M"). 3M is a covered federal contractor under President Biden's Executive Order 14042 ("EO 14042"), 6 Fed. Reg. 50,985-88 (Sept. 9, 2021), commonly known as the federal contractor vaccine mandate. The asserted purpose of EO 14042 is to promote economy and efficiency in the procurement of federal contracts.

In order to achieve its stated purpose of economy and efficiency in procuring federal contracts, EO 14042 is broadly written and promulgates various contractual conditions upon prospective federal contractors such as 3M. For example, EO 14042 requires that employees of covered federal contractors be vaccinated against COVID-19. EO 14042 also requires that covered federal contractors, such as 3M, require their covered employees to disclose their vaccination status and provide supporting documentation.

The day before this lawsuit was filed, a nationwide preliminary injunction was issued by a federal district court in Georgia on December 7, 2021, enjoining the federal government from enforcement of EO 14042. The Georgia district court did not reach any of the constitutional issues raised in that case, now on appeal before the Eleventh Circuit Court of Appeals.

Despite the nationwide injunction currently in effect that prevents covered employees from having to *take* a COVID-19 vaccination, 3M continues to compel the 3M Plaintiffs and all of 3M's United States employees to *disclose* their vaccination

status on or before January 4, 2022, or be reviewed for termination from employment. 3M is requiring this mandatory disclosure of its employees' vaccination status in participation with the directives of the federal government defendants, and in order to comply with EO 14042.

To achieve this compelled disclosure of its employees' vaccination status in concert with the government defendants as EO 14042 requires, 3M has implemented a third-party electronic platform called ShareMy.Health. This platform is designed by 3M to collect the vaccination status information and related documentation from all of its affected covered employees, including the 3M Plaintiffs.

Recent studies by the Kaiser Family Foundation ("KFF") have shown that an individual's vaccination status is a strong predictor of one's political affiliation. Cmplt., Doc. 1, Page ID ## 4-5. KFF is a nonprofit organization focusing on national health issues, as well as the U.S. role in global health policy. KFF develops and runs its own policy analysis, journalism and communications programs, sometimes in partnership with major news organizations.<sup>1</sup>

The 3M Plaintiffs do not wish to disclose their vaccination status to 3M and the federal government defendants because they believe such disclosure of their status amounts to disclosure of their disfavored political beliefs and will subject them to threats, reprisal, harassment, and retaliation from the government defendants and from 3M, including termination of their employment.

The First Amendment to the United States Constitution protects the right of

individuals to not speak or disclose certain information where they may be punished for their political affiliation. See Elrod v. Burns, 427 U. S. 347, 355-59 (1976). EO 14042's broad sweep requiring covered federal contractor employees to disclose their vaccination status is not narrowly tailored to achieve the government's asserted interest in promoting economy and efficiency in the procurement of federal contracts. See generally Ams. for Prosperity Found. v. Bonta, 141 S. Ct. 2373, 2389 (2021) (holding unconstitutional under the First Amendment a California law that required disclosure by charitable organizations of the identities of their major donors).

Further, EO 14042 is facially unconstitutional under the First Amendment because the vaccination status disclosure component does not form an integral part of the federal government's efforts to promote economy and efficiency in the procurement of federal contracts, and such interest does not justify EO 14042's required disclosure. *See id*.

The 3M Plaintiffs seek preliminary injunctive relief from this Court enjoining the federal government defendants, and 3M acting in concert with them in accordance with EO 14042, from requiring the 3M Plaintiffs to disclose their vaccination status or provide supporting documentation on or before January 4, 2022. This requested preliminary injunctive relief is not addressed by the nationwide injunction currently in effect and on appeal before the Eleventh Circuit Court of Appeals.

In addition to requiring the 3M Plaintiffs based in Texas and Minnesota to disclose their vaccination status in accordance with EO 14042, 3M is requiring all of its U.S. employees at covered 3M facilities and offices in 48 states (except in Delaware and Wyoming), two U.S. territories (Puerto Rico and Guam), and the District of Columbia, to disclose their vaccination status before January 4, 2022.

Accordingly, the 3M Plaintiffs seek this preliminary injunctive relief as applicable to these 48 states (including Texas and Minnesota), two U.S. territories, and the District of Columbia.

#### BACKGROUND

#### EO 14042's disclosure requirements

The Safer Federal Workforce Task Force COVID-19 Workplace Safety: Guidance for Federal Contractors and Subcontractors issued on September 24, 2021 ("Task Force Guidance"), provides guidance to federal contractors on implementing EO 14042. Specifically, as it relates to EO 14042's required disclosure requirements, the Task Force Guidance states as follows:

A covered contractor must review its covered employees' documentation to prove vaccination status. Covered contractors must require covered contractor employees to show or provide their employer with one of the following documents: a copy of the record of immunization from a health care provider or pharmacy, a copy of the COVID-19 Vaccination Record Card (CDC Form MLS-319813\_r, published on September 3, 2020), a copy of medical records documenting the vaccination, a copy of immunization records from a public health or State immunization information system, or a copy of any other official documentation verifying vaccination with information on the vaccine name, date(s) of administration, and the name of health care professional or clinic site administering vaccine. Covered contractors may allow covered contractor employees to show or provide to their employer a digital copy of such records, including, for example, a digital photograph, scanned image, or PDF of such a record. The covered contractor shall ensure compliance with the requirements in this Guidance related to the

showing or provision of proper vaccination documentation.<sup>2</sup>

#### <u>3M's ShareMy.Health Platform</u>

#### October 28, 2021

On October 28, 2021, 3M's Senior Vice President and Chief Corporate Affairs Officer, Denise Rutherford ("Rutherford"), sent an electronic mail communication to all 3M employees, including the 3M Plaintiffs, introducing 3M's new "ShareMy.Health" platform, where all 3M employees were required to disclose their vaccination status. This email from Ms. Rutherford began by stating:

> To comply with both COVID-19 vaccine mandates that the U.S. federal government announced in September, we are asking you to provide proof of vaccination.

#### October 29, 2021

The following day, 3M management communicated via electronic mail to all

affected 3M employees, including the 3M Plaintiffs, and stated as follows:

As previously communicated, 3M is partnering with ShareMy.Health to collect COVID-19 vaccine verification information in compliance with the federal vaccine mandate. ShareMy.Health enables 3M employees to upload specific health data in a protected, secure environment to help ensure your safety and well-being.

Please log in to ShareMy.Health no later than **December** 8 to indicate your current vaccination status and upload documents for verification. This system is 3M single-signon enabled; **please use** your <u>USxxxxx@mmm.com</u> or <u>Axxxxx@mmm.com</u> email address as your user ID and your standard 3M password.

In accordance to 3M's obligation to follow COVID-19 vaccine mandates set forth by the U.S. federal government, anyone at a location where employees are working on or connected to federal contracts (subject to limited medical and religious exemptions) must be vaccinated and have provided proof of vaccination by December 8, 2021. All 3M U.S. office locations fall into this category, as well as plant and distribution sites where federal contract work is done. Workers at our other U.S. sites will be obligated to comply with the upcoming OSHA emergency temporary standard once it is released and effective, which is likely to mean those workers will be required to be either vaccinated or subjected to weekly testing.

Reminder: If you wish to pursue a medical or religious exemption, please refer to instructions provided in previous communications and posted on 3M Go.

# Here's what we need from you:

1. Click here to activate your ShareMy.Health Account and sign in using your 3M credentials. Your account can be accessed at home or at work, from both corporate and personal computers and mobile devices. 2. To upload your vaccination information, click "Upload Your Vaccination" from your ShareMy.Health home page.

**3.** Once your vaccination has been reviewed you will receive an email notification, or you can check back to see the status.

For questions or concerns related to the federal vaccine mandate, refer to 3M Go or contact your local HR or Occupational Medicine representative.

For assistance uploading a health record please contact: 3msupport@sharemy.health

#### December 10, 2021

On December 10, 2021, two days after filing this suit and three days after the Georgia nationwide injunction was issued, Eric Hammes, 3M's Executive Vice President, Chief Country Governance and Services Officer ("Hammes"), sent an email to all 3M employees, including the 3M Plaintiffs. Mr.Hammes acknowledged the Georgia Court's nationwide injunction and that 3M employees were not required to be vaccinated at this time pending the outcome of that litigation. However, Mr. Hammes instructed all 3M employees including the 3M Plaintiffs to "continue to upload COVID-19 vaccination documents in the ShareMy.Health platform." See

#### <u>The 3M Plaintiffs</u>

The 3M Plaintiffs Conner, Dodson, Bachman, and Schiesl do not wish to disclose their vaccination status to 3M and the federal government defendants. These 3M Plaintiffs do not want to disclose such information because they believe such disclosure of their vaccination status amounts to disclosure of their disfavored political beliefs. They believe doing so will subject them to threats, reprisal, harassment, and retaliation from the government defendants and from 3M, including termination of their employment. *See generally* Appendix in Support of Instant Motion, at pp. 2, 15, 28, 41, Conner Decl., Dodson Decl., Bachman Decl., and Schiesl Decl.

#### LEGAL STANDARD

"A plaintiff seeking a preliminary injunction must establish that he is likely to succeed on the merits, that he is likely to suffer irreparable harm in the absence of preliminary relief, that the balance of equities tips in his favor, and that an injunction is in the public interest." *Winter v. Nat. Res. Def. Council, Inc.*, 555 U.S. 7, 20 (2008) (citations omitted); *see generally NetChoice, LLC v. Paxton*, No. 1:21-cv-840-RP, 2021 U.S. Dist. LEXIS 233460, 2021 WL 5755120, at \*9-10 (W.D. Tex. Dec. 1, 2021) (Pitman, J.) (granting preliminary injunction under the First Amendment because proposed statute impermissibly compels and chills protected speech). The party seeking injunctive relief carries the burden of persuasion on all four requirements. PCI Transp. Inc. v. W. R.R. Co., 418 F.3d 535, 545 (5th Cir. 2005).

#### ARGUMENT

# I. The current nationwide injunction in effect does not enjoin the government from requiring that covered federal contractors compel employees to disclose their vaccination status.

Immediate preliminary injunctive relief on the 3M Plaintiffs' First Amendment compelled political claim is necessary because the current nationwide injunction is inapplicable. That preliminary injunction does not enjoin these federal government defendants, nor 3M as a covered federal contractor acting in concert with the government defendants, from compelling disclosure of the 3M Plaintiffs' vaccination status on or before January 4, 2022. *See generally Georgia, et al v. Biden, et al.*, No. 1:21-cv-163, 2021 U.S. Dist. LEXIS 234032, 2021 WL 5779939 (S.D. Ga. Dec. 7, 2021).

#### A. In order to comply with the federal contractor vaccine mandate, the 3M Company is requiring its employees to disclose their vaccination status by January 4, 2022.

Despite its acknowledgment of the nationwide injunction in effect halting required vaccinations, in order to comply with EO 14042, 3M is still moving forward with requiring the 3M Plaintiffs and all 3M employees to disclose their vaccination status in the ShareMy.Health platform on or before January 4, 2022. *See generally* Appendix in Support of Instant Motion, at pp. 2, 15, 28, 41, Conner Decl., Dodson Decl., Bachman Decl., and Schiesl Decl.

# B. Studies have shown that a person's vaccination status is a strong predictor of political partisanship, and the First Amendment protects against compelled political speech.

The KFF study indicates that an individual's vaccination status is a strong predictor of one' political affiliation. Cmplt., Doc. 1, Page ID ## 4-5. Indeed, there is a high correlation that disclosing one's vaccination status will reveal one's political party affiliation. The KFF COVID-19 Vaccine Monitor study revealed that 60% of unvaccinated individuals are more inclined to be aligned with the Republican party, and those that are vaccinated are clearly aligned in much greater percentages with the Democratic party or identify as Independents. <sup>3</sup>

President Biden is mandating vaccination against COVID-19 through EO 14042, and is in favor of mandatory vaccinations from a political policy perspective. President Biden is a long-standing Democrat, and his views on mandatory vaccinations are consistent with the KFF COVID-19 study that revealed this political partisanship divide between Republicans, Democrats, and Independents. President Biden has made clear in public remarks that he disfavors those individuals such as the 3M Plaintiffs that remain unvaccinated against COVID-19, and he feels like he has struck a "brick wall" in trying to convince such unvaccinated individuals be vaccinated<sup>4</sup>

# II. Injunctive relief is appropriate and necessary to remedy the government's ongoing violation of fundamental Constitutional rights.

As the Supreme Court has held, "[i]f there is any fixed star in our constitutional

constellation, it is that no official, high or petty, can prescribe what shall be orthodox in matters of politics, nationalism, religion, or other matters of opinion or force citizens to confess by word or act their faith therein." *West Virginia State Board of Education v. Barnette*, 319 U.S. 624, 642 (1943). As Justice Jackson opined, "[t]hose who begin coercive elimination of dissent soon find themselves exterminating dissenters. Compulsory unification of opinion achieves only the unanimity of the graveyard." *Id.* at 641.

Much like OSHA's Emergency Temporary Standard ("ETS") vaccination or testing mandate for employers with 100 or more employees that the Fifth Circuit recently struck down, President Biden's EO 14042 "grossly exceeds" his executive authority. *See BST Holdings, L.L.C. v. OSHA*, 17 F. 4th 604, 611 (5th Cir. Nov. 12, 2021).

Here, the 3M Plaintiffs are being forced and compelled by 3M and the federal government defendants to disclose their vaccination status in accordance with EO 14042, an act that amounts to compulsory disclosure of one's political affiliation. The First Amendment is clear that this is a prohibited infringement and facially unconstitutional. President Biden and the federal government defendants have not promulgated EO 14042 in a narrowly tailored manner to survive constitutional exacting scrutiny for the stated purpose of efficient federal contracting, and the 3M Plaintiffs are entitled to preliminary injunctive relief.

# A. The 3M Plaintiffs are likely to succeed on the merits of their First Amendment claim.

Disclosure requirements such as the EO 14042 vaccination compelled

disclosure can chill association even if there is no disclosure to the general public. *See* generally Bonta, 141 S. Ct. 2373. This compelled disclosure has been identified by the Supreme Court in numerous cases to infringe upon the First Amendment. *Id*.

EO 14042 will infringe upon the 3M Plaintiffs' First Amendment right to not disclose their vaccination status, and the 3M Plaintiffs are likely to succeed on the merits of this claim.

# B. Without preliminary injunctive relief, the 3M Plaintiffs will suffer irreparable harm.

"The loss of First Amendment freedoms, for even minimal periods of time, unquestionably constitutes irreparable injury." *Roman Cath. Diocese of Brooklyn v. Cuomo*, 141 S. Ct. 63, 67 (2020) (quoting *Elrod v. Burns*, 427 U.S. at 347, 373 (1976)). The 3M Plaintiffs will suffer irreparable harm if this Court does not issue injunctive relief prior to the January 4, 2022, required compelled disclosure date of their vaccination status. Moreover, 3M will review their vaccination status, which amounts to a disfavored political disclosure, and proceed with the 3M Plaintiffs' termination of employment.

# C. The 3M Plaintiffs' injuries outweigh any potential hardship to the government.

The federal government defendants lack a compelling state interest for EO 14042. Thus, it will not be harmed, nor suffer any potential hardship. *See Texans for Free Enter. v. Texas Ethics Comm'n*, 732 F.3d 535, 539 (5th Cir. 2013).

#### D. Granting injunctive relief will serve the public interest.

Courts have found that "injunctions protecting First Amendment freedoms are

always in the public interest." *Id.* (quoting *Christian Legal Soc'y v. Walker*, 453 F.3d 853, 859 (7th Cir. 2006)).

#### CONCLUSION

For the foregoing reasons, the 3M Plaintiffs seek a temporary restraining

order and preliminary injunction, enjoining the federal government defendants and

3M from acting in concert with them, from compelling the 3M Plaintiffs to disclose

their vaccination status on or before January 4, 2022.

My name is Michael Schiesl, and I declare as follows:

Affairs Officer, Denise Rutherford ("Rutherford"), sent an electronic mail communication to all 3M employees introducing 3M's new "ShareMy.Health" platform, where all 3M employees were required to disclose their vaccination status, attached hereto as <u>Exhibit A</u>.

3. On October 29, 2021, 3M management sent a follow-up email

instructing 3M employees to upload and disclose their vaccine status information on the ShareMy.Health platform, that is substantially in the same form as set forth in the supporting brief filed with my declaration.

Mr.Hammes acknowledged the GA nationwide injunction and that 3M employees were not required to be vaccinated at this time pending the outcome of that litigation. However, Mr. Hammes instructed all 3M employees including me to "continue to upload COVID-19 vaccination documents in the ShareMy.Health platform." 3M has not disclosed how it is protecting the safety and privacy of data 3M employees share on the ShareMy.Health platform system.

5. I do not wish to disclose my vaccination status to 3M and the federal government defendants on or before January 4, 2022 because I believe such disclosure of my status amounts to disclosure of my disfavored political beliefs and will subject me to threats, reprisal, harassment, and retaliation from the government defendants and from 3M, including termination of my employment.

6. Per the <u>Exhibit B</u> excel spreadsheet, 3M is requiring its employees in 48 states (except in Delaware and Wyoming), two U.S. territories (Puerto Rico and Guam), and the District of Columbia, to disclose their vaccination status.

- If you are an hourly-paid employee, please make every effort to complete this task while you are at work. If you are unable to do so, please discuss with your local HR representative.
