26	I, C. ERIN FRIDAY, declare as follows:			
27	1. I am an attorney at law licensed to practice in the State of California and am a

licensed attorney and of counsel with the Law Offices of Nicole C. Pearson, attorney of record 1 for Petitioners PROTECT KIDS CALIFORNIA and JONATHAN ZACHRESON 2 ("Petitioners"). 3 2. My declaration is submitted in support of the Petitioners' Writ Petition. I have 4 personal knowledge of the matters set forth below and, if called as a witness, could and would 5 testify competently to them under oath. 6 7 I am a member of the executive committee for the Protect Kids of California Ballot 3. 8 Initiative that has been given the title "RESTRICTS RIGHTS OF TRANSGENDER YOUTH" 9 and designation 23-0027A2 (the "Initiative"). 10 To date, 23 states (with a 24th state likely to follow suit) in the nation have passed 4. 11 legislation that safeguards children's natural bodies, sexual function and ability to procreate. The 12 titles of the acts or laws are all framed in a neutral or in a positive manner – highlighting that the 13 14 bills are protecting children. See Request for Judicial Notice. 15 5. I performed legal research using Casetext. I searched the term "female" in the 16 California Regulations The search engine located 185 Regulations that use the term "female" and 17 they all appear to use the term relative to those persons or animals whose bodies are developed 18 for production of large gametes whether or not eggs are produced. 19 6. I performed legal research using Casetext. I searched the term "female" in the 20 California codes. The search engine located 153 statutes that use the term "female". The usage 21 22 of the term "female" in these statutes relate to those humans with biological female bodies whose 23 bodies are developed to produce large gametes, including but not limited to Welfare and 24 Institutions Code §1753.7 [addressing female and menstrual products]; Insurance Code §790.03 25 [referencing life insurance annuities for females as distinguished from males]; the Penal Code 26 §318.6 [addressing exposure of female breasts for crimes related to sexual infractions] and Cal. 27 Pen. Code § 273.4, an act penalizing those for female genital mutilation which means "the 28

excision or infibulation of the labia majora, labia minora, clitoris, or vulva" body parts only 1 related to females. 2 7. On January 14, 2024, Korey Wells emailed Protect Kids California asking "How 3 do you expect this to have any change to win with a title that says 'restrict rights? Where is 4 5 your lawsuit challenging this title? . . . nobody will support something that's framed as a negative." 6 7 8. Exhibit 1 is a true and correct copy of the email from Mr. Wells with his email address redacted. 8 9. I have been gathering signatures to place the Initiative on the California ballot. 9 10. I have had to explain to at least 10 potential signatories what the term 10 "transgender female" means because they are confused as to whether that term means that the 11 person (a) was born female and adopted a male gender identity, or (b) was born male and 12 13 adopted a female gender identity. 14 I declare under penalty of perjury under the laws of the State of California that the 15 foregoing is true and correct.
