children are experiencing mental distress, (b) protect girls' sports and spaces from biological men, and (c) prevent child sterilization through harmful medical procedures.

- I was in support of all three aspects of the Initiative intended to protect children.
- 5. I later read the initial title and summary for the Initiative drafted by Protect Kids California. It was thoughtfully crafted, and I believed that it would gain widespread support and eventually appear on the ballot in November 2024.
- I spoke to many people who also seemed enthusiastic about supporting the Initiative and indicated their willingness to sign when the time came.
- However, upon reading the Official Title and Summary prepared by Attorney General Rob Bonta which rewrote a title focused on "protecting kids" into a title about "restricting rights," I became immediately concerned that this official description would cause the Initiative to fail.
- Many people I spoke to changed their minds about signing the Initiative due to the 8. language of the Official Title and Summary.
- It was clear to me that although public polling indicated strong majority support for the policies proposed by the Initiative, very few people approve of the idea of "restricting rights."
- The Attorney General's title and summary is intended to subvert the true intent of 10. the Initiative - to protect the rights of children - and misrepresent it as an Initiative which will violate the civil rights of others in order to alienate potential supporters.
- It is my opinion that most Californians will only read the Official Title before 11. determining whether to support the Initiative, and therefore only be presented with the Attorney General's biased language that they will be reluctant to sign.
- It is my opinion that the Attorney General has effectively edited the message of the 12. Initiative in a conscious attempt to cause the Initiative to fail.
- I have personal knowledge of the facts stated herein, except where stated upon 13. information and belief, and as to those facts, I believe them to be true.
